Registration:

Purchase Insurance

All participants are required to purchase insurance through our governing body, USARS (USA Roller Sports). The annual membership fee of \$85 is paid directly to USARS. Primary health insurance is strongly encouraged.

Please [Click here](#) to purchase the **Full Competition Membership – Adults** and select **Derby Devils Inc – TX024RD** when registering. Included in the USARS registration process is a 1-hour training for SafeSport. This training must be completed for your membership to be active.

Pay Skater Dues

The **annual league membership** fee of **\$25** is due by the end of February. If you join after August, there will not be an annual fee due.

New Skater Underworld program - \$120 - This program is a training course for all new skaters. Underworld is the place for anyone ages 14+ interested in learning the sport of roller derby, trying out for a home team, interested in being a referee or just working on your skating and roller derby skills.

Existing/Returning Adult (14+) Skaters - Monthly dues are **\$30** and are due on the 1st of each month. Dues are considered late if not received by the 15th of each month.
